BE IT FURTHER RESOLVED, that a sum not to exceed Two Million Dollars (\$2,000,000.00), ~~be and it is hereby~~ authorized as a subsidy to said corporation for public transportation purposes from Department 46, Public Transportation Fund 257, said sum of \$2,000,000.00, to include the cash advance to the San Diego Transit Corporation of Two Hundred Thousand Dollars (\$200,000.00), approved by this Council on September 14, 1972 through Resolution No. 206534.
