

RESOLUTION NO. 206621

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Lake Murray Boulevard over and across a portion of Lot 4, Navajo Shopping Center, according to Map thereof No. 4721, filed February 23, 1971, in the office of the San Diego County Recorder; and

WHEREAS, the owner of the property has requested an exchange of abutter's rights be made to allow better utilization of the land; and

WHEREAS, the value of the property rights to be exchanged are equal as determined by a staff appraiser of The City of San Diego, being the sum of \$75.00 each; and

WHEREAS, it is in the public interest that said exchange be made and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 741491, to the

OWNERS IN FEE SIMPLE OF RECORD of Lot 4, Navajo Shopping Center, effecting the revestment of those abutter's rights of access to Lake Murray Boulevard of said Lot 4, Navajo Shopping Center, heretofore relinquished to The City of San Diego, more particularly described in said form of quit-claim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City ~~be and he is hereby authorized and directed to deliver~~ said deed and a certified copy of this resolution to the Mayor of said City for execution and transmittal to the Property Director of said City for recordation.
