That the acceptance by the City Manager of that deed of ROBERT C. BARTLETT as trustee pursuant to Declaration of Trust dated April 24, 1970, known as the Ernest L. Bartlett Family Trust; and ROBERT C. BARTLETT as trustee under the Ernest L. Bartlett Family Trust dated November 1, 1967, executed in favor of The City of San Diego, bearing date of September 11, 1972, conveying to said City Lot 2 in Block 17 of Tract No. 2 of Encanto Heights, according to Map thereof No. 1100, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$15,000 from Park Bond Fund 725 and \$28,000 from Capital Outlay Fund 245 is hereby approved for the acquisition of the above property for the Encanto Park and Recreation Center Addition.

That the City Clerk be and he is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Director for recordation and further handling.
