
Adopted on OCT 8 1972

EDWARDS, an individual, for full time services for the purpose of assisting the City Manager, City Attorney, Water Utilities Department, and other departments concerned with public utility matters, from November 1, 1972 to October 31, 1973, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741542.

BE IT FURTHER RESOLVED, that the expenditure of \$24,600 is hereby authorized out of Water Operating Fund 500 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above consultant services.
