BE IT FURTHER RESOLVED, that the transfer of \$75,000.00 within the Sewer Revenue Fund 506 from the Unallocated Reserve (68.91-3494) to Sewer Engineering (65.94-3295) to be expended solely and exclusively for the above purposes is hereby authorized.
