WHEREAS, The City of San Diego and the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, entered into a freeway maintenance agreement on file in the office of the City Clerk as Document No. 651223, dated January 18, 1963 which established maintenance responsibilities at six locations where City facilities intersected State Route 8; and

WHEREAS, the above parties mutually desire to amend said agreement to establish maintenance responsibilities as to the CAMINO DEL RIO OVERCROSSING which traverses State Route 8; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the freeway maintenance agreement on file in the office of the City Clerk as Document No. 651223, with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, establishing maintenance responsibilities where the CAMINO DEL RIO OVERCROSSING intersects State Route 8, under the terms and conditions set forth in the form of amendment to freeway maintenance agreement on file in the office of the City Clerk as Document No. 741545.
