BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized to accept the proposal of Wainwright & Ramsey, municipal finance consultants, to continue to develop a series of water rate designs reflecting the impact of transferring Metropolitan Water District and San Diego County Water Authority taxes from water revenues to the property tax originally authorized in Resolution No. 205294 in the manner and for the compensation set forth in that letter dated September 27, 1972, from Wainwright & Ramsey, a copy of which is on file in the office of the City Clerk as Document No. 741557.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$4,000 within the Water Operating Fund 500 Reserve (67.49-3495) to Professional Services (67.27-3295) solely and exclusively for the above mentioned purpose.
