

RESOLUTION NO. 206006

WHEREAS, a petition on file in the office of the City Clerk as Document No. 740821, has requested the formation of a Park Northeast Open Space District pursuant to the San Diego Park District Procedural Ordinance of 1969; and

WHEREAS, said petition at this point in time is insufficient to initiate the appropriate procedures as said petition contains signatures representing only 54.2% of the assessable land in the proposed district; and

WHEREAS, this Council, in view of the property owner interest expressed in said petition, may desire to initiate proceedings on its own motion to create and establish the above referenced Park District as permitted under the aforesaid Procedural Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby directed to prepare plans, drawings and specifications for the acquisition, improvement and maintenance of that area of the City of San Diego generally described as: all that real property, consisting mainly of canyon areas, which is adjacent to and lying westerly of Interstate 15, easterly of 31st Street, northerly of Ash Street, and southerly of Redwood Street, said area to be designated

as San Diego Park District No. 7 (Park Northeast Open Space District), together with the estimated costs and expenses of such work, and to furnish this Council with a description of the District and a plat showing the exterior boundaries of the District to be included in the assessment for the work and improvement hereinabove mentioned; said work is contemplated to be done under the San Diego Park District Procedural Ordinance of 1969.

BE IT FURTHER RESOLVED, that an Environmental Impact Report be prepared, submitted and approved pursuant to the Environmental Quality Act of 1970 prior to any action on the formation of an Open Space District.
