

RESOLUTION NO. 206668

WHEREAS, the Council of The City of San Diego on May 18, 1972, by Resolution No. 205628, designated a survey area for the project entitled "Linda Vista Shopping Center Redevelopment Project," pursuant to Section 33310 of the Community Redevelopment Law, Health and Safety Code of the State of California; and

WHEREAS, a preliminary plan is prepared and is under consideration by the Planning Commission of The City of San Diego for Linda Vista Shopping Center Redevelopment Project, pursuant to Section 33322 of the Health and Safety Code of the State of California; and

WHEREAS, it is now necessary for the Redevelopment Agency and the Council of The City of San Diego to hold a public hearing and adopt a redevelopment plan for the Linda Vista Shopping Center Redevelopment Project; and

WHEREAS, Section 33355 of the Health and Safety Code of the State of California provides that as an alternative to a separate public hearing, the City Council and the Redevelopment Agency may, with the consent of both bodies, hold a joint public hearing on the redevelopment plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Council of The City of San Diego does hereby consent to a joint public hearing as provided for by Sections 33355 through 33359 of the Health and Safety Code of the State of California.

2. That November 7, 1972 is designated as the date for the joint hearing by the City Council and the Redevelopment Agency of The City of San Diego.
