APPROVING MAP OF ISAAC SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by R.S. PALM, Registered Civil Engineer, and entitled "ISAAC SUBDIVISION Being a subdivision of the northerly 226.96 feet of Lot 5 and all of Lot 6, excepting the northerly 30.00 feet therefrom, in Tibbetts Tract, in the City of San Diego, County of San Diego, State of California, according to Licensed Survey Map No. 24, filed in the office of the County Recorder of San Diego County, November 25, 1892.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of a drainage facility, as granted and shown on said map and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that that easement with the right of ingress and egress for the construc-

tion and maintenance of a drainage facility, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
