APPROVING MAP OF TORREY PINES HEIGHTS SUBDIVISION UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS S.W. WONG, Registered Civil Engineer, and entitled "TORREY PINES HEIGHTS SUBDIVISION UNIT NO. 2 Being a subdivision of a portion of Lot 4, Section 23, and a portion of the Southwest Quarter of the Southwest Quarter of Section 24, all in Township 14 South, Range 4 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the street, to wit: Del Mar Scenic Parkway for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners for: the construction and maintenance of drainage and water facilities, general utilities, and open space, as granted and shown on said map and subject to the conditions expressed therein.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 21 and 22, and Lot 41 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected those portions of Lots 21 and 22, and Lot 41 marked "Reserved for Future Street" as shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
