

RESOLUTION NO. 206700

WHEREAS, The City of San Diego is the owner of certain easements for drainage, open space and general utility purposes affecting portions of Lot 1 and 3 of Colina La Jolla, according to Map thereof No. 6464 filed in the office of the San Diego County Recorder on August 29, 1969; and

WHEREAS, the owner of said Lots 1 and 3 of Colina La Jolla has requested an exchange of easements to allow better utilization of the land; and

WHEREAS, the easements to be acquired will serve the same uses and purposes as the easements to be quitclaimed; and

WHEREAS, the value of the property rights to be exchanged are equal as determined by Property Department staff, being the sum of \$100 each; and

WHEREAS, it is in the public interest that said exchange be made and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of, and as the act and deed of The City of San Diego, an Agreement Exchanging Easements with Marview

Investors, Ltd., a limited partnership, the form of which agreement is on file in the office of the City Clerk as Document No. 741559, exchanging existing easements for drainage, open space and general utility and access purposes affecting Lots 1 and 3 of Colina La Jolla, as more particularly described in said form of agreement.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby authorized and directed to deliver said agreement and a certified copy of this resolution to the Property Director of The City of San Diego for further handling.
