That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with CENTRAL CITY ASSOCIATION OF SAN DIEGO, INC., a California nonprofit corporation, SAN DIEGO TRANSIT CORPORATION, a California nonprofit corporation, and SAN DIEGO CONVENTION AND VISITORS' BUREAU, a California nonprofit corporation, to make available to the public a downtown public information center, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741561.

BE IT FURTHER RESOLVED, that the expenditure of \$9,638 is hereby authorized out of Transient Occupancy Tax Fund 223 solely and exclusively for the purpose of providing funds for the services stated above.
