

RESOLUTION NO. 206705

WHEREAS, this City Council has determined that a new schedule of charges for public sewer connections should be established in order to reimburse City for all costs of material, labor, equipment and any other costs incidental to the performance of this service; and

WHEREAS, the City Manager, pursuant to San Diego Municipal Code, Section 64.13, has made his recommendations concerning said fee schedule; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That pursuant to San Diego Municipal Code, Section 64.13, the following fee schedule and rules shall be used for charging for City connections to public sewers:

CONNECTION TO PUBLIC SEWERS - WORK TO BE DONE  
BY DEPARTMENT OF WATER UTILITIES - FEES AND  
CHARGES ESTABLISHED

The owner or applicant for connection shall pay to the City for construction and laying of laterals the following charges:

SEWER CONNECTION CHARGES

4" Street	\$360*
6" Street	400**
4" Alley	250***
6" Alley	270****
Property Connection	15
Private Permit Connection	25

\*Maximum 40 ft. \$7.00 per ft. footage overrun  
\*\*Maximum 40 ft. \$7.50 per ft. footage overrun  
\*\*\*Maximum 15 ft. \$7.00 per ft. footage overrun  
\*\*\*\*Maximum 15 ft. \$7.50 per ft. footage overrun

The above charges are for installations under normal conditions. Whenever an installation involves a difficult excavation or other exceptional procedure an additional charge may be established by the Director of Water Utilities as appropriate.

Installations may be done by others except for Property Connections and Private Permit Connections.
