APPROVING MAP OF FASHION HEIGHTS UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, Licensed Land Surveyor, and entitled "FASHION HEIGHTS UNIT NO. 1 Being a subdivision of portions of the Pueblo Lots 1174 and 1175 of The Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which said Map as filed in the office of the County Recorder of San Diego County and known as Miscellaneous Map No. 36, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets and portion of street, to wit: Fashion Hills Boulevard, Glidden Street, and a portion of Ulric Street, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1, 2 and 3 of the certificate

signed by the Owners for: construction and maintenance of water, drainage, and sewer facilities, general utilities, and open space; as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; that those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
