BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within the 100 Fund the sum of three hundred sixty dollars (\$360) from Unallocated Reserve (53.30) to the Planning Department (Dept. 12.00, Object Account 3213) solely and exclusively for the above purpose.
