BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file a certified copy of this resolution in the office of the San Diego County Recorder.

LEGAL DESCRIPTION OF STREET.
RESERVATION TO BE DEDICATED

All that portion of Lot 1, Sample-Brown Tract in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 4123, filed in the Office of the County Recorder of San Diego County, March 20, 1959, shown as "Reserved for Future Street", more particularly described as follows:

Beginning at the Northeasterly corner of Lot 1, also being a point on the arc of a 4,128.00 foot radius curve, concave Northerly, a radial to said point bears South 12°43'36" East; thence South 00°09'11" West, 252.80 feet to the most Southeasterly corner of said Lot 1; thence South 75°54'21" West, 69.84 feet to a point of cusp on the arc of a 50.00 foot radius curve, concave Northwesterly; thence Northeasterly along the arc of said curve through a central angle of 75°45'10", 66.11 feet; thence tangent to said curve North 00°09'11" East, 214.84 feet to an intersection with the arc of said 4,128.00 foot radius curve, concave Northerly, also being the Northerly line of said Lot 1; thence Easterly along the arc of said curve through a central angle of 00°25'37", 30.76 feet to the Point of Beginning.

ALSO:

All that portion of Lot 1, San Diego Hiway House in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4258, filed in the Office of the County Recorder of San Diego County, June 10, 1959, shown as "Reserved for Future Street", more particularly described as follows:

Commencing at the Northwesterly corner of said Map No. 4258, also being a point on the arc of a 4,128.00 foot radius curve, concave Northerly, a radial to said point bears South 12°43'36" East; thence South 00°09'11" West, 8.20 feet to the TRUE POINT OF BEGINNING; thence continuing South 00°09'11" West, 244.60 feet; thence South 00°36'45" East, 37.69 feet to a point of cusp on the arc of a 106.00 foot radius curve, concave Northwesterly, a radial to said point bears South 49°15'47" East; thence Northerly along the arc of said curve through a central angle of 40°35'02", 75.08 feet; thence tangent to said curve North 00°09'11" East, 203.53 feet to the beginning of a tangent curve, concave Southeasterly; thence North-easterly along the arc of said tangent curve through a central angle of 76°33'26", 26.72 feet to a point of cusp on the arc of a 4,136.00 foot radius curve, concave Northerly; thence Westerly along said curve through a central angle of 00°35'18", 42.47 feet to the TRUE POINT OF BEGINNING, a radial to said point bears South 12°42'05" East.
