BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a lease agreement with EARL S. TOBEY, an individual, for operation of restaurant facilities at Balboa Park Municipal Golf Course, wherein City will receive 5% of gross income monthly against a minimum annual rent of \$4,400, for a term of five (5) years commencing October 1, 1972, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741706.
