Robert L. Davis	PUBLIC WORKS DEPARTMENT Buildings Division	\$20	This suggester, a Plumber, proposed that Polaroid pictures be taken of plumbing, electrical and carpentry work in walls or floors before they are sealed. This will enable parts to be located later when work on them becomes necessary.
Charles N. Guthrie Hie A. Thompson	POLICE DEPARTMENT	\$15	These officers proposed and arranged for many other officers to get copies of the AMA auto identification manual (free) which are of considerable help in the recovery of stolen vehicles.
Eugene I. Kinkead	PUBLIC WORKS DEPARTMENT	\$10	This Equipment Mechanic designed a manifold to be installed in the hydraulic lines of Heil packer trucks in order to reduce maintenance time on ejector blade repairs. This is an initial award, and when savings can be determined a large additional award may be in order.
Joseph F. Young	PUBLIC WORKS DEPARTMENT	\$10	A \$15 award was made to this Carpenter about a year ago for suggesting purchase of a special panel saw for large sheets of material. Actual savings for the first year warrant an additional \$10 award.
