

RESOLUTION No. 206780

Adopted on OCT 24 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a lease agreement with SARATOGA DEVELOPMENT CORPORATION, a California corporation and land developer, for use of the former California Division of Forestry Fire Station located one-half mile north of Miramar Road and one-half mile east of Black Mountain Road, as a City fire station, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741766.

That the City Manager be and he is hereby authorized to accept for and on behalf of The City of San Diego the contribution of \$5,000 from Leadership Housing Systems, Inc., a New York corporation, to defray relocation costs in accordance with the agreement and performance bond on file in the office of the City Clerk as Document No. 740920, bearing date of July 20, 1972.

That the City Manager be and he is hereby authorized and directed to use City forces to render the aforesaid fire station habitable for Fire Department occupancy.
