That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO COUNTY WATER AUTHORITY for the installation of a water service connection and meter to serve The City of San Diego Miramar Water Filtration Plant, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741721.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to expend the sum of \$97,800 from Water Revenue Fund 502 solely and exclusively for the above mentioned purpose.
