RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 202833 FOR THE IMPROVEMENT OF LINDA VISTA ROAD BETWEEN TAIT STREET AND GENESEE AVENUE AND ULRIC STREET BETWEEN TAIT STREET AND LINDA VISTA ROAD.
