RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DECLARING ITS INTENTION TO ORDER CHANGES AND MODIFICATIONS IN THE WORK PROPOSED TO BE DONE UNDER RESOLUTION OF INTENTION NO. 202833 IN THE MATTER OF THE IMPROVEMENT OF LINDA VISTA ROAD BETWEEN TAIT STREET AND GENESEE AVENUE AND ULRIC STREET BETWEEN TAIT STREET AND LINDA VISTA ROAD.

WHEREAS, this Council did on June 1, 1971, pursuant to the Municipal Improvement Act of 1911, adopt Resolution of Intention No. 202833 declaring its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings referred to therein, and did provide, in addition to a City of San Diego contribution, for a portion of said costs to be assessed against the district described in said Resolution of Intention; and

WHEREAS, pursuant to said Resolution of Intention, a public hearing was conducted on July 6, 1971, with full opportunity being afforded to all protestants desiring to be heard to voice their objections; and

WHEREAS, subsequent to said public hearing this Council did order the improvements described in the above referenced Resolution of Intention and in conjunction therewith did award a contract to the R. E. Hazard Contracting Company; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the

proposed work to be done under said Resolution of Intention;
NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San
Diego, as follows:

Section 1. That the public interest, convenience and
necessity require and it is the intention of this Council to
order the changes and modifications as more particularly described
and shown on City of San Diego Engineering Drawings Nos. 14234-1
through 14234-13D, consisting of thirteen (13) sheets, filed in
the office of the City Clerk under Document No. 741741,
which are incorporated herein and which shall govern for all
details thereof.

Section 2. The estimated cost of the aforesaid changes
and modifications is a decrease of \$2,627.68 and an increase of
\$7,833.55, amounting to a net increase of \$5,205.87 in the cost
of the work.

Section 3. NOTICE IS HEREBY GIVEN that NOV 14 1972,
1972, at 9:30 o'clock a.m., in the Council Chambers of the City
Administration Building, Community Concourse, 202 C Street, in
the City of San Diego, California, are hereby fixed as the time
and place when and where any and all persons having any objections
to the proposed changes and modifications herein proposed may
appear and show cause why said changes and modifications should
not be done and carried out in accordance with this Resolution
of Intention to Modify.

Section 4. That the Clerk of said City be and he is hereby directed to cause this Resolution of Intention to be published at least ten (10) days before the date of said hearing in the City's official newspaper, a daily newspaper published and circulated in said City.
