

RESOLUTION NO. 206798

OCT 26 1972

WHEREAS, on March 14, 1972, by Resolution No. 205121, the City Council authorized the execution of an Option Agreement between City and Mira Mesa Shopping Center giving the City a two-year option to purchase a 21.499 acre site for a park and recreation center to serve East Mira Mesa as a community park; and

WHEREAS, on September 26, 1972, by Resolution No. 206594, the City Council authorized the City Manager to exercise the aforesaid option and on the same day, by Resolution No. 206596, authorized the expenditure of \$507,300 out of Park Service District Fund No. 11220 to cover all acquisition costs necessary to acquire the property for the aforesaid park; and

WHEREAS, pursuant to said Option Agreement, Mira Mesa Shopping Center has delivered to City against payment of the purchase price a grant deed to said property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the acceptance by the City Manager of that deed of MIRA MESA SHOPPING CENTER, a partnership, executed in favor of The City of San Diego, bearing date of September 22, 1972, conveying to said City a portion of the Northeast

Quarter of Section 36, Township 14 South, Range 3 West,
as more particularly described in said deed, be and the same
is hereby approved.

That the City Clerk of said City is hereby authorized
and directed to transmit, upon acceptance by the City
Manager, the foregoing said deed to the Property Director
of The City of San Diego for recordation and further
disposition.
