

RESOLUTION NO. 206814 OCT 31 1972

WHEREAS, the preliminary plan concept for this Tijuana River Valley has been accepted by the City Council at this time as a basis for proceeding with further feasibility investigations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council requests the International Boundary and Water Commission to direct the U.S. Army Corps of Engineers to study alternative designs to the extent necessary to protect the valley from the effects of the Mexican Channelization work which is now in progress, and to identify cost benefits for provision of flood protection necessary to implement the preliminary plan concept.
