


**RESOLUTION No.** 206818

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$9,351.80 by Silver Strand Contractors, a partnership, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY COMMERCIAL STREET, 28TH STREET, SAMPSON AVENUE, OCEAN VIEW BOULEVARD, AND EVANS STREET (E.D.A. Project No. 07-11-01227) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 740914.
2. That the expenditure of \$12,000 is hereby authorized out of the Special Fund 2714 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY COMMERCIAL STREET, 28TH STREET, SAMPSON AVENUE, OCEAN VIEW BOULEVARD, AND EVANS STREET in the City of San Diego, and related costs.
