RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES
AND MODIFICATIONS IN THE WORK FOR THE IMPROVEMENT
OF 40TH STREET, IMPERIAL AVENUE AND FRANKLIN AVENUE
AS DESCRIBED IN RESOLUTION OF INTENTION NO. 202111.

WHEREAS, this City Council did on March 9, 1971,
adopt its Resolution of Intention No. 202111, declaring
its intention to order the construction of certain improve-
ments in the City of San Diego; and

WHEREAS, this City Council did on October 3, 1972,
adopt its Resolution No. 206642 proposing to make
certain changes and modifications in the work as described
in said Resolution of Intention; and

WHEREAS, the hearing has been held on said proposed
changes, all in the manner and form prescribed by law, and
objections not having been made by the owners of one-half of
the area of the property proposed to be assessed, and the
contractor having filed a written consent to the making of
said changes, and this Council now having jurisdiction to
make said changes and modifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Section 1. Public interest and convenience require
certain changes and modifications in the work for the
assessment district originally set forth in Resolution of
Intention No. 202111, which changes and modifications are
duly described and set forth in Resolution No. 206642,

adopted by this Council on October 3, 1972 This Council hereby orders said changes and modifications as set forth in said last noted resolution.

Section 2. That the contract for said improvement entered into for the doing of the work shall be modified to include modifications ordered by this resolution.
