

RESOLUTION NO. 206837

NOV 2 - 1972

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on July 12, 1972, continued it to August 23, 1972, to consider the proposed LA JOLLA SHORES PRECISE PLAN, prepared by the Planning Department in cooperation with the Planned District Committee of the La Jolla Shores Association and interested citizens of this area of the City; and

WHEREAS, the plan is a refinement of the adopted La Jolla Community Plan (Document No. 709762) and primarily addresses itself to the establishment of guidelines for the development of a future planned district to maintain the quality of existing development and conserve the natural amenities for that area generally located westerly of Gilman Drive, southerly of Scripps Institute of Oceanography, and northerly of Mount Soledad; and

WHEREAS, although there are certain conclusions made regarding the present condition of traffic circulation which are not considered completely accurate, the LA JOLLA SHORES PRECISE PLAN as a whole is desirable; and

WHEREAS, the Planning Commission approved the LA JOLLA SHORES PRECISE PLAN and recommended adoption by the Council of The City of San Diego; and

WHEREAS, the Council of The City of San Diego held a public hearing on October 3, 1972, continued it to November 2, 1972, to consider the LA JOLLA SHORES PRECISE PLAN; and

WHEREAS, the City Council amended the LA JOLLA SHORES
PRECISE PLAN as approved by the Planning Commission to add the
following as paragraph 11 at page 7:

Property which is presently developed under a
planned residential development permit or a planned
unit development permit should continue to be subject
to the terms of these permits and the architectural
controls within each development, and should not be
subject to architectural control by any district
formed to implement the La Jolla Shores Precise Plan.

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby adopts as the LA JOLLA SHORES PRECISE
PLAN that document which is on file in the office of the City Clerk
as Document No. 741809.
