WHEREAS, the Council of The City of San Diego adopted the LA JOLLA COMMUNITY PLAN by Resolution No. 190107 on April 13, 1967; and

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on July 12, 1972, continued it to August 23, 1972, at which meeting the Planning Commission voted 4 to 1 to approve adoption of an amendment to the LA JOLLA COMMUNITY PLAN as contained in the La Jolla Shores Precise Plan; and

WHEREAS, the Council of The City of San Diego held a public hearing on October 3, 1972, continued it to November 2, 1972, to consider an amendment to the LA JOLLA COMMUNITY PLAN, as contained in the La Jolla Shores Precise Plan; and

WHEREAS, the City Council approved the La Jolla Shores Precise Plan, a copy of which is on file in the office of the City Clerk as Document No. 741809; NOW, THEREFORE,
