RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REGARDING CALIFORNIA'S BALLOT
PROPOSITION 14 OF THE NOVEMBER 7, 1972
GENERAL ELECTION.

WHEREAS, Proposition 14 (the Watson Initiative) imposes arbitrary tax rate limitations upon local agencies without providing any remedy to those agencies whose expenditures exceed the revenue generated by the maximum tax rates allowed; and

WHEREAS, any property tax reduction provided by the initiative would benefit large landowners at the expense of single family homeowners whose property tax reductions would be substantially more than offset by increased user taxes specified in the initiative needed to compensate for the statewide deficit the initiative would create; and

WHEREAS, the initiative contains no provisions which would insure that renters would get any tax relief whatsoever;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council opposes this measure and urges all registered voters to vote against this potentially devastating initiative on November 7, 1972.
