That the City Clerk is directed to prepare various plans for redistricting the City Council districts on the basis of population, such redistricting plans to be in compliance with the order of the Superior Court in the Case of D'Adamo v. Cobb, Superior Court No. 314629.

BE IT FURTHER RESOLVED, that the redistricting process be in accord with the schedule which is attached hereto as Exhibit "A"; said schedule giving a week's leeway to meet deadlines established in the Order of the Court.

Tues., 12-26-72	CONTINUED COUNCIL HEARING. (COUNCIL directs Attorney to prepare ORDINANCE approving a plan.)
Tues., 1-2-73	CONTINUED COUNCIL HEARING. (COUNCIL INTRODUCES ORDINANCE approving a plan.)
Tues., 1-16-73	COUNCIL ADOPTS ORDINANCE.
