That the City Manager is hereby authorized and empowered to do by City forces all the work of installing a new remote control panel in the new aircraft control tower at Brown Field in the City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$4,841 is hereby authorized out of Brown Field Special Aviation Fund 239 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project.
