APPROVING MAP OF SCRIPPS MESA CENTER UNIT NO. 3 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by M. KENT JOHNSON, Registered Civil Engineer, and entitled "SCRIPPS MESA CENTER UNIT NO. 3 Being a subdivision of a portion of the Northwest Quarter and a portion of the Southwest Quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Meridian, according to official plat thereof, together with a portion of Mary Ellen Road as dedicated to public use in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets and portion of street, to wit: Scripps Ranch Boulevard, Treena Street, and a portion of Hibert Street, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
