

**RESOLUTION No. 206911**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of FRANCISCO OROZCO and CONSUELO C. OROZCO, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of June 21, 1972, conveying to said City an easement and right of way for street purposes through, over, under, along and across the Westerly 6.00 feet of the Northerly 49.00 feet of the Southerly 99.00 feet of Lot A-245 of Addition No. 5 to San Ysidro, according to the Map thereof No. 1405, filed January 2, 1912 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named AVERIL ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
