BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to advance tuition costs from the Unallocated Reserve (100/53.30) amounting to \$55,500 for thirty (30) Police Lieutenants and Police Captains to attend the P.O.S.T. Middle Management Course and sixty (60) Middle Managers to attend the P.O.S.T. Middle Management Seminars to be conducted locally by California State University at Long Beach and LaVerne College; these advance payments to be reimbursed by P.O.S.T. after completion of the courses, including approximately \$71,500 in salary reimbursements.
