Jennings	PUBLIC WORKS DEPARTMENT Buildings Division	\$280	The suggester, a Plumber, proposed the installation of a sand trap at the base of public drinking fountains to eliminate the constant maintenance caused by sand being put in the fountains. This has been found in over a year of use to effectively solve the problem. A net saving of \$2,800 in maintenance costs has been made in the first year.
Charles W. Kilgore	POLICE DEPARTMENT	\$220	After a continuing two year effort, the suggesting officer and his department have obtained approval of the District Attorney's Office to eliminate the admonishment form and report required for arrests. Over 36,000 such reports have been eliminated, saving about \$2,200 per year in time and forms.
