1. That the bid of \$17,898.00 by Wilcox Electric Inc. dba Arrow Electric, a corporation for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF EUCLID AVENUE AND SOLOLA AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the office of the City Clerk as Document No. 741512.
2.
