That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with TUDOR ENGINEERING COMPANY, a California corporation, for a comprehensive engineering reconnaissance study of the Tijuana River Valley to determine the feasibility of restoring to agricultural use the bulk of lands situated in the United States lying within the Tijuana River Valley, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741966.

BE IT FURTHER RESOLVED, that the expenditure of \$6500 is hereby authorized from Environmental Growth Fund 2505 solely and exclusively to provide funds for the purposes stated above.
