1. That the bid of \$10,423.00 by DBX, Inc. dba Perry Electric, a Corporation, for the CONSTRUCTION OF SAFETY LIGHTING SYSTEMS ON TORREY PINES ROAD FROM PROSPECT STREET TO HIDDEN VALLEY ROAD UNDERGROUND CONVERSION DISTRICT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 741514.
2.
