BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$9,212.50 by Sapper Construction Company, a Corporation, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS ON SAN YSIDRO BOULEVARD BETWEEN INTERSTATE 5 NORTHERLY TO SYCAMORE ROAD AND IN THE AREA BOUNDED BY SAN YSIDRO BOULEVARD, EAST PARK AVENUE, HALL AVENUE AND EAST OLIVE AVENUE (E.D.A. Project No. 07-11-01227, Contract 11) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 741588.
2. That the expenditure of \$12,000 is hereby authorized out of the Special Fund No. 2714 of the City of San Diego, California solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS ON SAN YSIDRO BOULEVARD BETWEEN INTERSTATE 5 NORTHERLY TO SYCAMORE ROAD AND IN THE AREA BOUNDED BY SAN YSIDRO BOULEVARD, EAST PARK AVENUE, HALL AVENUE AND EAST OLIVE AVENUE in the City of San Diego, and related costs.
