

RESOLUTION NO. 206970 DEC 5 1972

APPROVING MAP OF MIRA MESA VILLAGE UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "MIRA MESA VILLAGE UNIT NO. 1 Being a subdivision of a portion of the Northwest Quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved September 11, 1879.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; that said Council hereby accepts on behalf of the public, the portion of street, to wit: portion of Mira Mesa Boulevard, for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mira Mesa Boulevard adjacent and contiguous to Lot 1; in and to the frontage road adjacent and contiguous to Lot 1, all as shown and granted on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
