

RESOLUTION NO. 206981 DEC 5 1972

WHEREAS, this Council did on October 19, 1971, by Resolution No. 203998, establish the College Avenue Underground Utility District which required the conversion of certain overhead facilities; and

WHEREAS, such district was created in conjunction with the proposed development of Princess Del Cerro--Unit No. 6 where it was contemplated that the street improvements and undergrounding would occur simultaneously; and

WHEREAS, the proposed development has not occurred within the anticipated time period, and The City of San Diego has been requested by the Pacific Telephone Company to temporarily exempt two telephone poles and associated facilities located on Lance Street from the district; and

WHEREAS, Section 61.0510 of the San Diego Municipal Code provides procedures for the granting of special permission by the Council to any person or utility company to maintain certain overhead facilities and structures within a district; and

WHEREAS, the facts set forth above are deemed to constitute unique and unusual circumstances and the granting of said special permission to Pacific Telephone Company for the maintenance and use of the above-referenced poles on Lance Street will not be detrimental to the public health, safety and general welfare; and

WHEREAS, the City Manager recommends the granting of such special permission; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Pacific Telephone Company is hereby granted permission to maintain, use and operate two Pacific Telephone Company-owned poles and associated overhead facilities within the College Avenue Underground Utility District at the locations shown on the attached plat and made a part hereof. Such grant of permission shall be temporary and revocable in nature and shall terminate at such time as the improvements on Lance Street adjacent to Princess Del Cerro--Unit No. 6 are undertaken.

2. That Resolution No. 203998 be and the same is hereby amended to reflect the said exceptions granted herein.
