

RESOLUTION NO. 207008 DEC 5 1972

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, a portion of Carroll Canyon Road (Road Survey 466) in Sections 3 and 4, T. 15 S., R. 3 W., S.B.B.M., has been relocated through the approval and dedication on this date of a revised alignment for this portion of Carroll Canyon Road, as more particularly shown on Drawing No. 15341-D, on file in the office of the City Clerk as Document No. 742101; and

WHEREAS, those properties adjoining that portion of Carroll Canyon Road to be vacated will continue to have access or will be accessible by the alternate route dedicated on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Carroll Canyon Road in Sections 3 and 4, T. 15 S., R. 3 W., S.B.B.M., as more particularly shown on Drawing No. 15340-D, on file in the office of the City Clerk as Document No. 742102, which said drawing is attached hereto and made a part hereof, be and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
