1. That the bid of \$7,987.50 by Silver Strand Contractors, a Partnership, for the CONSTRUCTION OF SIDEWALKS ON BOSTON AVENUE BETWEEN 38TH STREET AND 41ST STREET AND ON 40TH STREET 120 FEET SOUTHERLY OF BOSTON AVENUE (E.D.A. Project No. 07-11-01227) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 740917.
2. That the expenditure of \$10,000 is hereby authorized out of the Special Fund No. 2714 of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SIDEWALKS ON BOSTON AVENUE BETWEEN 38TH STREET AND 41ST STREET AND ON 40TH STREET 120 FEET SOUTHERLY OF BOSTON AVENUE in the City of San Diego, and related costs.
