That Change Order No. 2, dated August 8, 1972, heretofore filed with the City Clerk of said City as Document No. 742126, issued in connection with the contract between The City of San Diego and Allied Mechanical Contractors for the Metro Pump Station No. 1, Bar Screen Installation, said contract having been filed as Document No. 729200, in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$7,389.00, and an extension of time of 987 days extending the completion to August 30, 1972, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$7,389.00 from the Sewer Revenue Fund 506, be and it is hereby authorized solely and exclusively for the purpose of providing funds for the contract changes described above.
