A RESOLUTION TO ESTABLISH A MODEL CITIES LIAISON COMMITTEE TO FACILITATE COMMUNICATIONS WITHIN THE SAN DIEGO MODEL CITIES PROGRAM

WHEREAS, the City has entered into a contract with the Department of Housing and Urban Development of the United States of America for a grant to carry out within the City of San Diego, a Model Cities Program; and

WHEREAS, Section 102 (a) (2) of the Demonstration
Cities and Metropolitan Development Act of 1966 and HUD
Citizen Participation Policy for Model Cities Programs
(MC 31.35.1; MCGR 3100.3) call upon the City to create a
citizen participation component which must be actively and
continuously involved in planning, monitoring, evaluating
and influencing the Model Cities Program and, in good
faith deliberation with its citizen participation component,
to define clearly and set forth the responsibilities and
authority of the citizen participation component in these
areas; and

WHEREAS, the City recognizes that the tradition of citizen participation in the governing process is older than the founding of the Republic and that although the form of government may alter over time, the need for citizen participation in the governing process does not change; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That a Liaison Committee be established to facilitate communications between resident representatives and City

Council representatives.

- 2. That the Liaison Committee be composed of the Chairman plus two members of the Citizens Advisory Board, the Mayor, and two Councilmen.
- 3. That the Liaison Committee meet on a regular monthly basis at such a time and place as mutually agreed upon.
- 4. The Liaison Committee shall submit periodic reports to the Council concerning Model Cities.
