


RESOLUTION No. 207029

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$15,150 by H & H Contractors, Inc., a Corporation, for the construction of COMPRESSED AIR SYSTEM EXTENSION, OPERATIONS KIOSK AND MISCELLANEOUS REMODELING, SAN DIEGO TRANSIT CORPORATION, San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 741590.
2. That the expenditure of \$17,000 is hereby authorized out of the Transit Central Operating Facility Fund No. 2572 of the City of San Diego solely and exclusively for the purpose of providing funds for the construction of COMPRESSED AIR SYSTEM EXTENSION, OPERATIONS KIOSK AND MISCELLANEOUS REMODELING, SAN DIEGO TRANSIT CORPORATION, San Diego, California, and related costs.
