That the acceptance by the City Manager of that deed of LOCDEL, INC., a California corporation, executed in favor of The City of San Diego, bearing date of July 27, 1972, conveying to said City portions of Section 26, Township 18 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named NORSTAD STREET.

That the expenditure of \$50.00 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds to cover all acquisition costs necessary to acquire the aforesaid real property.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
