

RESOLUTION NO. 207047 DEC 12 1972

A RESOLUTION ESTABLISHING AN UNDERGROUND UTILITY DISTRICT TO BE KNOWN AND DENOMINATED AS THE COLLEGE AVENUE (EL CAJON BOULEVARD TO UNIVERSITY AVENUE) UNDERGROUND UTILITY DISTRICT.

WHEREAS, by Resolution No. 206896, a public hearing was called for on DEC 12 1972 at the hour of 9:30 a.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety or general welfare requires the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within that certain area of the City of San Diego more particularly described as follows:

The easterly 50 feet of Log Realty Subdivision, Map No. 5132; Lots 55 through 66 and the westerly 50 feet of Lots 67 through 72 and all of Lot 73, Gilcher Tract, Map No. 1829; the westerly 25 feet of Lot 1, El Cerrito Terrace Unit No. 1, Map No. 2713; the easterly 25 feet of Lots 10 and 11, and street closing in Block 16, and the easterly 25 feet of Lots 11 and 12, and street closing, Block 17, El Cerrito Heights Unit No. 2, Map No. 2010; that portion of Lot 19, Rancho Mission, Map No. 299, bounded by: the easterly line of College Avenue, a line 50 feet easterly and parallel to the easterly line of College Avenue, the southerly line of Adelaide Avenue and the northerly line of Block F, Russell Heights Tract 4, Map No. 3067; the westerly 50 feet of Lots 1 through 4, Block F,

feet of Lots 75 and 76, College Avenue Tract No. 3, Map No. 2518; the easterly 50 feet of Record of Survey 3066; that portion of Parcel "00," portion of Lot 19, Rancho Mission, Record of Survey 1404, bounded by: the southerly line of Lot 61, College Avenue Tract No. 3, Map No. 2518, the northerly line of University Avenue, the easterly line of College Avenue and a line 100 feet easterly and parallel to the easterly line of College Avenue; that portion of Parcel "00," portion of Lot 19, Rancho Mission, Record of Survey 1404, bounded by: the southerly line of University Avenue, the easterly line of College Avenue, a line 198 feet easterly and parallel to the easterly line of College Avenue, and a line 125 feet southerly and parallel to the southerly line of University Avenue;

Said district shall include the following described public rights of way:

COLLEGE AVENUE, between the southerly line of El Cajon Boulevard and the southerly line of University Avenue; UNIVERSITY AVENUE, between the westerly line of College Avenue and line 200 feet easterly and parallel to the easterly line of College Avenue; ESTELLE STREET, between the westerly line of College Avenue and the southerly prolongation of the easterly line of College Way; ACORN STREET, between the easterly line of College Avenue and a line 50 feet easterly and parallel to the easterly line of College Avenue; COLLEGE WAY, between the easterly prolongation of the northerly line of Lot 44, Gilcher Tract and the westerly line of College Avenue; MEADE AVENUE, between the westerly line of College Avenue and a line 75 feet westerly and parallel to the westerly line of College Avenue; and PECK PLACE, between the easterly line of College Avenue and a line 50 feet easterly and parallel to the easterly line of College Avenue;

and all as more particularly shown on Drawing No. 15424-D, entitled COLLEGE AVENUE (EL CAJON BOULEVARD TO UNIVERSITY AVENUE) UNDERGROUND UTILITY DISTRICT, copies of which are on file in the office of the City Clerk as Document

No. 741885 and attached hereto and incorporated herein as Exhibit A; and

WHEREAS, notice of such hearing has been given by the City Clerk to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Council does hereby find and determine that the public health, safety and general welfare require the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the area set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above-described area is hereby declared to be an underground utility district in the City of San Diego, and the map and document referred to above are hereby incorporated as a part of this resolution.

2. The City Council does hereby order the removal of all poles, overhead wires and associated overhead structures and

the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within said District. The date upon which property in the District must be ready to receive underground service, and for removal of all poles, overhead wires and associated overhead structures shall be fixed and designated by a subsequent resolution, all as set forth in Section 61.0508, San Diego Municipal Code.

3. Notice of the adoption of the resolution fixing the time within which conversions on private property and pole removal must be accomplished shall be given by the City Clerk and City Manager in accordance with Section 61.0511(b) of the San Diego Municipal Code.


4. The City Clerk be and he is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code and all affected utility companies of the adoption of this Resolution No. 207047 within fifteen (15) days after the date of such adoption. The City Clerk specifically shall notify the affected persons that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall provide, at their own expense, all necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public

Utilities Commission of the State of California (as of the date of adoption of this resolution) and subject to all other applicable requirements of State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.

5. The City Council hereby finds that the underground utility district created herein is required by the public health, safety and general welfare for the following reason:

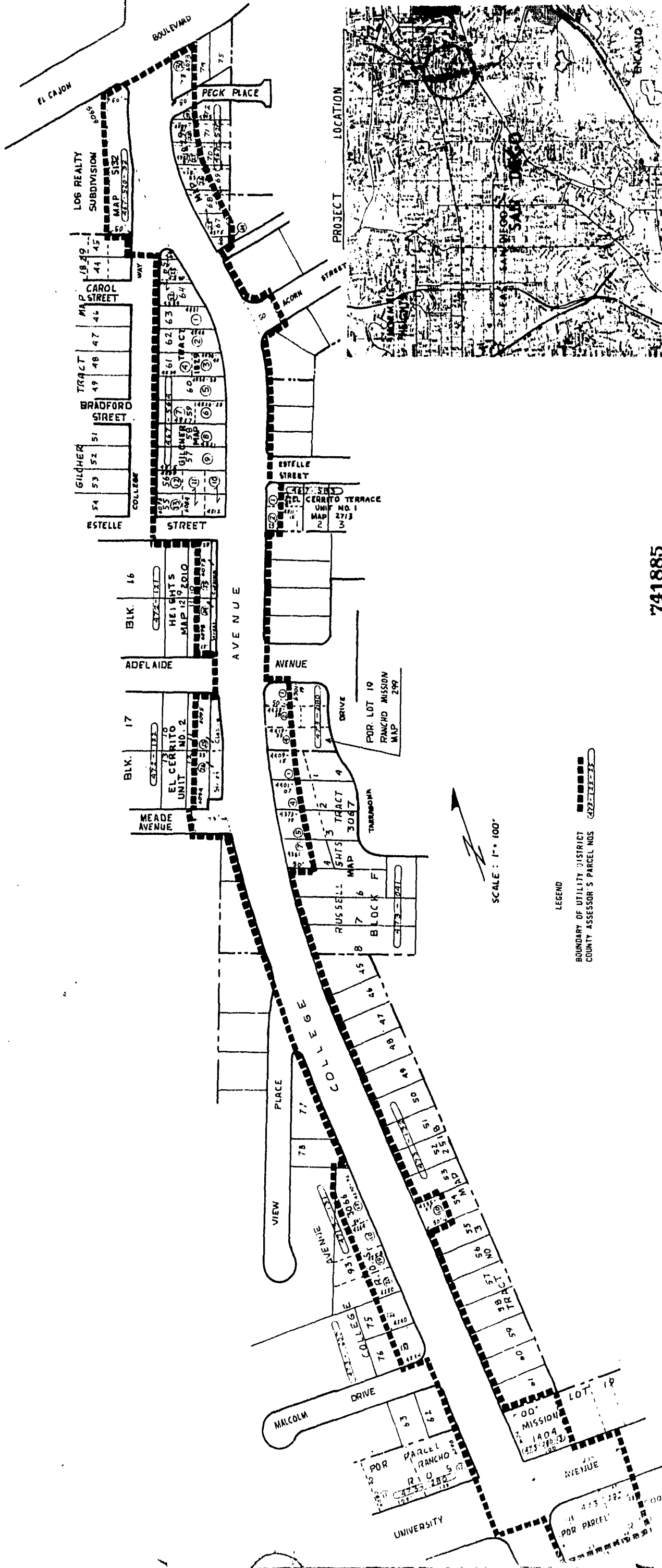
This street is extensively used by the general public and carries a heavy volume of pedestrian and vehicular traffic.
