

RESOLUTION OF INTENTION NO. 207049

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE LEE, BOUNDARY, LOURET AND ANITA AVENUES AND PORTIONS OF MARIAN, CHARLES AND ALAMITOS AVENUES AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the streets hereinafter mentioned; and in connection therewith require the reservation of certain easements for sewers in the area covered by such streets.


BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of LOURET AVENUE between 19th and Hollister Streets; CHARLES AVENUE between 19th Street and the southerly prolongation of the westerly line of Lot 26, Block 3, Marian subdivision; and MARIAN AVENUE between the northerly prolongation of the easterly line of Lot 4, Block 1, Marian subdivision and Alamitos Avenue (all of the above excepting any portion within the right of way of Interstate 5); and also LEE AVENUE between Boundary Avenue and the easterly prolongation of the southerly line of Lot 14, Garden Villa Tract; BOUNDARY AVENUE between Lee Avenue and 19th Street; ANITA AVENUE between Louret and Marian Avenues; and ALAMITOS AVENUE between Louret and Charles Avenue as more particularly shown on Map No. 15165-D, on file in the office of the City Clerk as Document No. 742118.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 9:30 a.m., JAN 9 1973,  
in the Council Chambers on the twelfth floor of the City Administra-  
tion Building, Community Concourse, 202 C Street, in said City of  
San Diego, as the time and place for hearing all persons interested  
in or objecting to the proposed vacation; and

That The Daily Transcript, a daily newspaper published and  
circulated, and of general circulation, in the said City of San Diego,  
be and it is hereby designated as the newspaper in which the Street  
Superintendent of said City shall cause to be published, in the  
manner and form required by law, notice of the passage of this  
Resolution of Intention, and the said Street Superintendent is  
hereby directed to cause notices of the passage of this resolution  
to be posted in the manner and form required by law and to cause  
a notice similar in substance to be published in said newspaper in  
the manner required by law.
